Consequently, peace in the society starts from the grassroots, which are the individuals in the family. It is only when individuals are filled with peace that they can give same out to the society. If all families are due with peace, no doubt, it will have a ripple over effect to the society. On the contrary, where there is no peace in the life of individuals, it will not be possible for the society to experience peace. In general, no one can give what he/she does not have. Women are carriers and sowers of peace seed: "by their fruits you know them," a mango tree produces mangoes, so do other trees after their own kind.

A woman is the architect, bearer and pruner of fruits in the family and home. Women are the centre stage holding the families together as they possess the binding force that closes individual gaps in the home. Therefore, if any thing happens that a woman is removed from her position in the family, such family automatically looses balance, since they are custodians of values in such households. The home that loses balance becomes a harbinger of disorder and disaster. Their position in the family is sensitive to functions of peace moves and sustenance from the home platform to societal outburst.

However, if the custodian is not in good order, the entire household becomes dysfunctional and the general society will collapse as a result.
